 - a. In Matter No. 001-2022 regarding the charges brought by Chief James Pfister, Complainant against Officer Scott Thomas, Respondent, the Board shall hold an Evidentiary Hearing in Closed Session.
 - b. Consider/act on Closed Session pursuant to Wis. Stat. §19.85(1)(a) (deliberating concerning a case which was the subject of a quasi-judicial hearing before the governmental body); and Wis. Stat. §19.85(1)(b) (considering dismissal, demotion, licensing or discipline of any public employee or person licensed by a board or commission or the investigation of charges against such person, or considering the grant or denial of tenure for a university faculty member, and the taking of formal action on any such matter; provided that the faculty member or other public employee or person licensed is given actual notice of any evidentiary hearing which may be held prior to final action being taken and of any meeting at which final action may be taken; specifically to deliberate the matter of charges brought by Chief James Pfister against Officer Scott Thomas. **PLEASE NOTE:** Officer Scott Thomas has the right to demand that the evidentiary hearing or meeting be held in open session.
 - c. The Commission may reconvene into Open Session to receive any additional necessary testimony or evidence regarding the charges brought by Chief James Pfister against Officer Scott Thomas.
 - d. The Commission may again convene into Closed Session pursuant to Wis. Stat. §19.85(1)(a) (deliberating concerning a case which was the subject of a quasi-judicial hearing before the governmental body); Wis. Stat. §19.85(1)(b) (considering dismissal, demotion, licensing or discipline of any public employee or person licensed by a board or commission or the investigation of charges against such person, or considering the grant or denial of tenure for a university faculty member, and the taking of formal action on any such matter); Wis. Stat. §19.85(1)(c) (considering employment, promotion, compensation or performance evaluation data of any public employee over which the governmental body has jurisdiction or exercises responsibility); and Wis. Stat. §19.85(g) (conferring with legal counsel for the governmental body who is rendering oral or written legal advice related to pending litigation); specifically to deliberate regarding any additional testimony or evidence regarding the matter of charges brought by Chief James Pfister against Officer Scott Thomas.
 - e. Consider/act to reconvene into Open Session to consider any remaining agenda items and to take action, if appropriate, regarding the items discussed in Closed Session.
